Insert the **Table Leg Assemblies (BAE)** into the **Brace Assemblies (BAF)**. Before inserting the Legs, ensure the plastic locating pin in the Bushing sticks through the hole in the Braces Assemblies (Detail 1). Ensure the Push-buttons in the Table Leg Assemblies snap into the holes in the Brace Assemblies. If the Push-buttons are facing the wrong direction, re-insert them correctly.



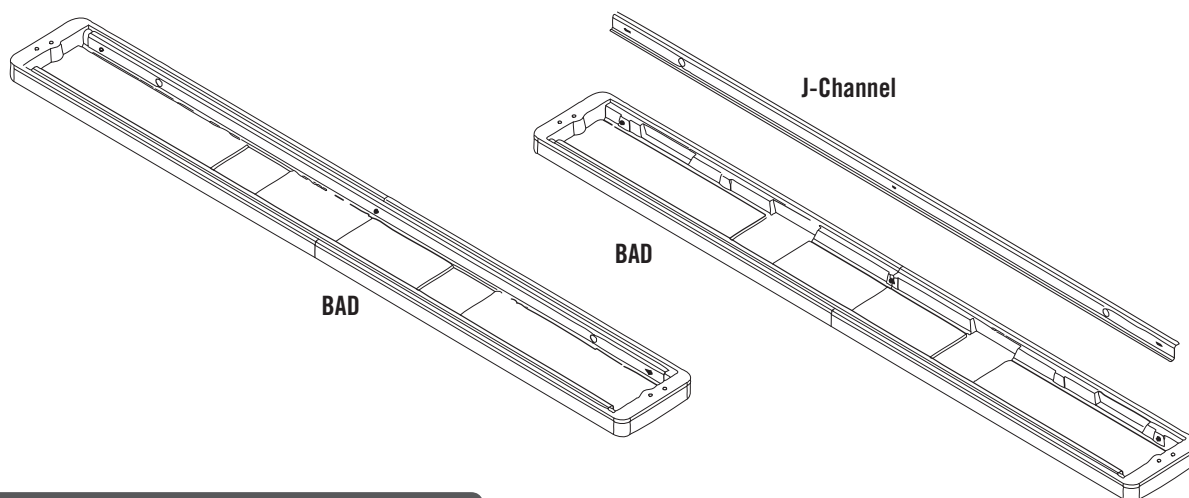

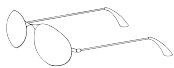
### \*\*TWO ADULTS REQUIRED FOR THIS STEP\*\*

Tighten the Screws only until the head of the Screw makes contact with the J-Channel. **Repeat Steps 1.8 through 1.10 to attach the other Bench.**





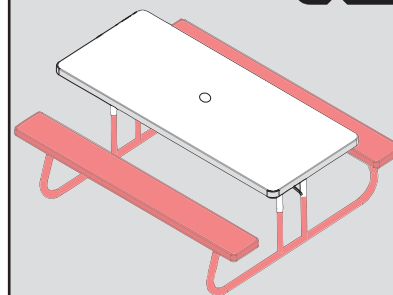

To prevent the **Leg Latches (BAG)** from dangling when the Table is set up (Figure 1), slide the Latches toward the ends of the table (Figure 2) so they are in the position shown in Figure 3. If you have an umbrella, insert it through the hole in the Table Top, or insert the **Umbrella Hole Plug (BBZ)** to cover the hole.

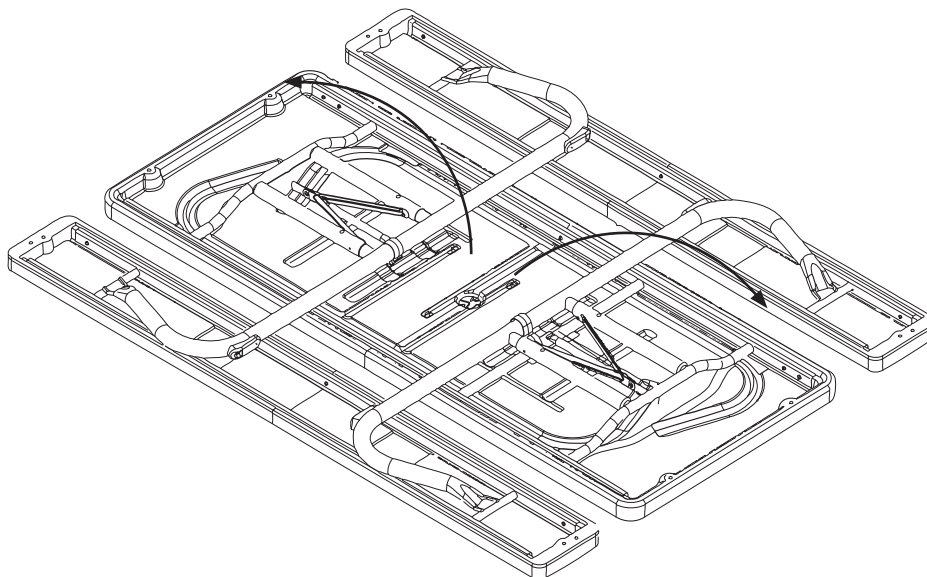

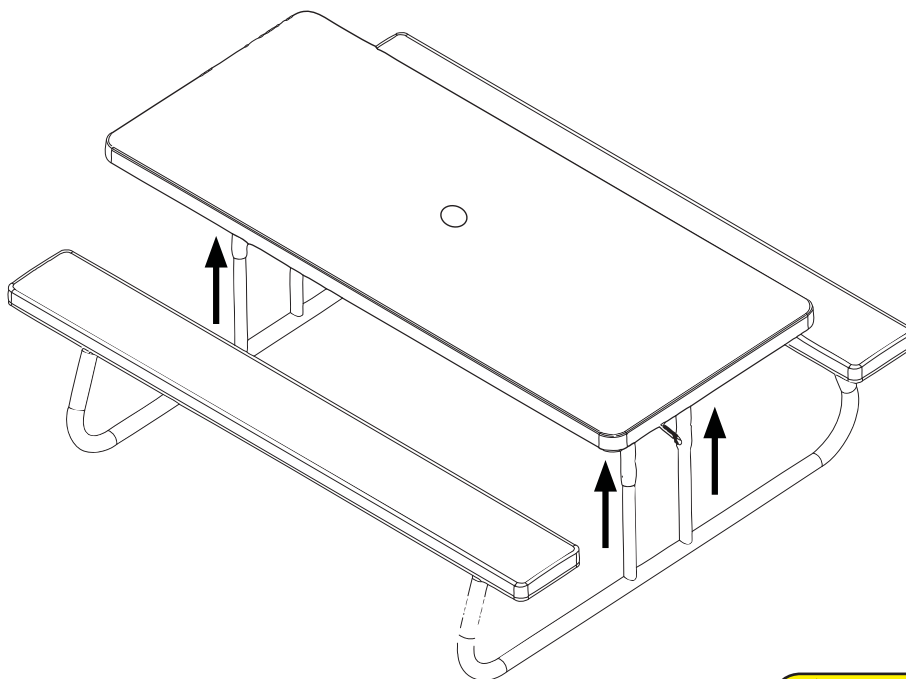
Unfold Table legs and lock them in place.

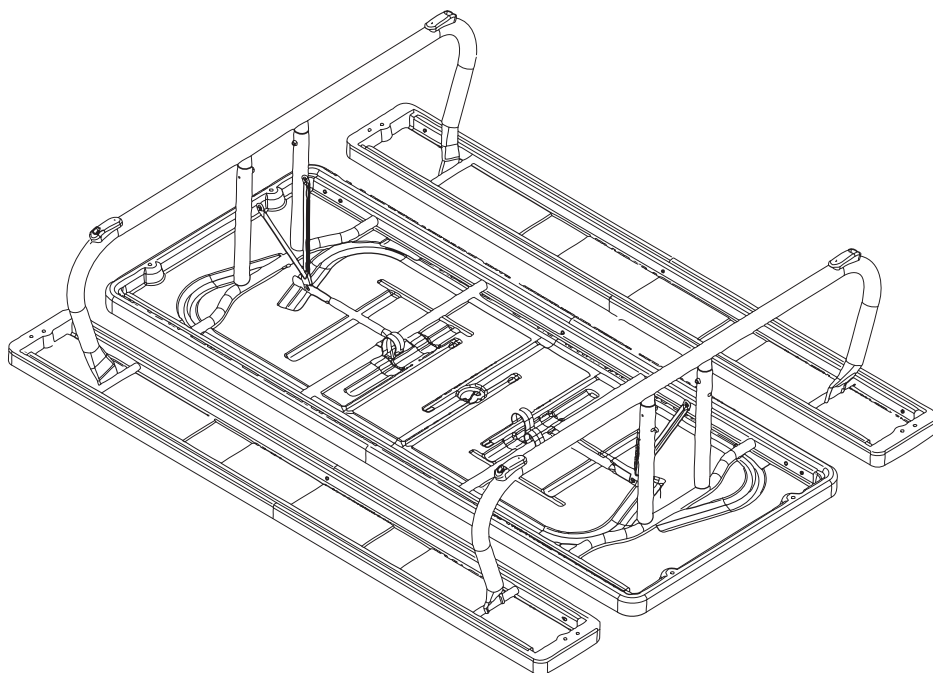

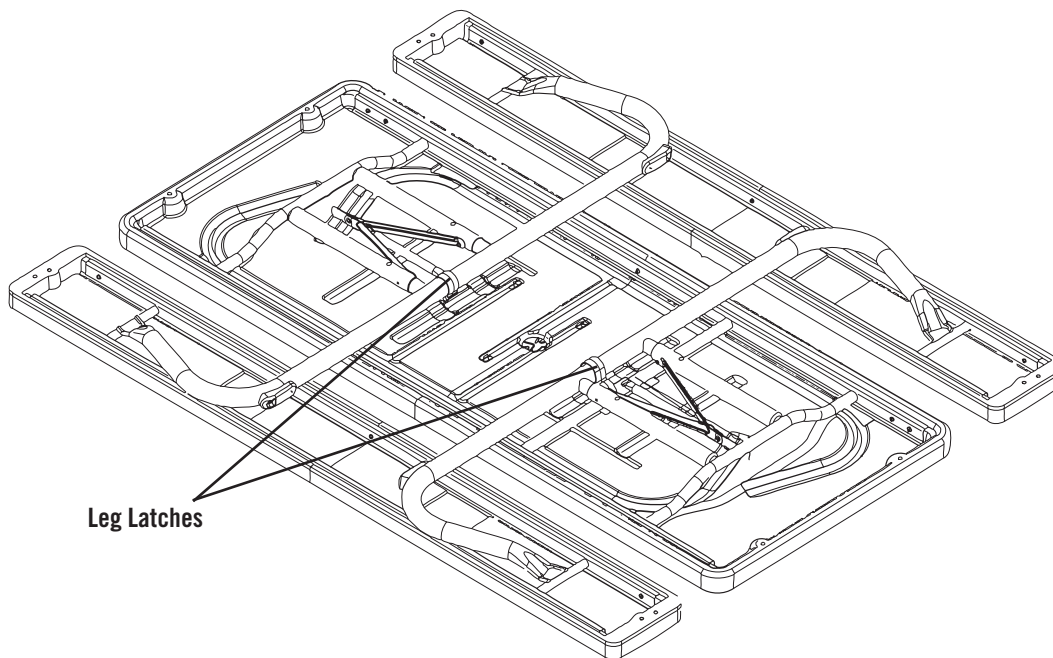

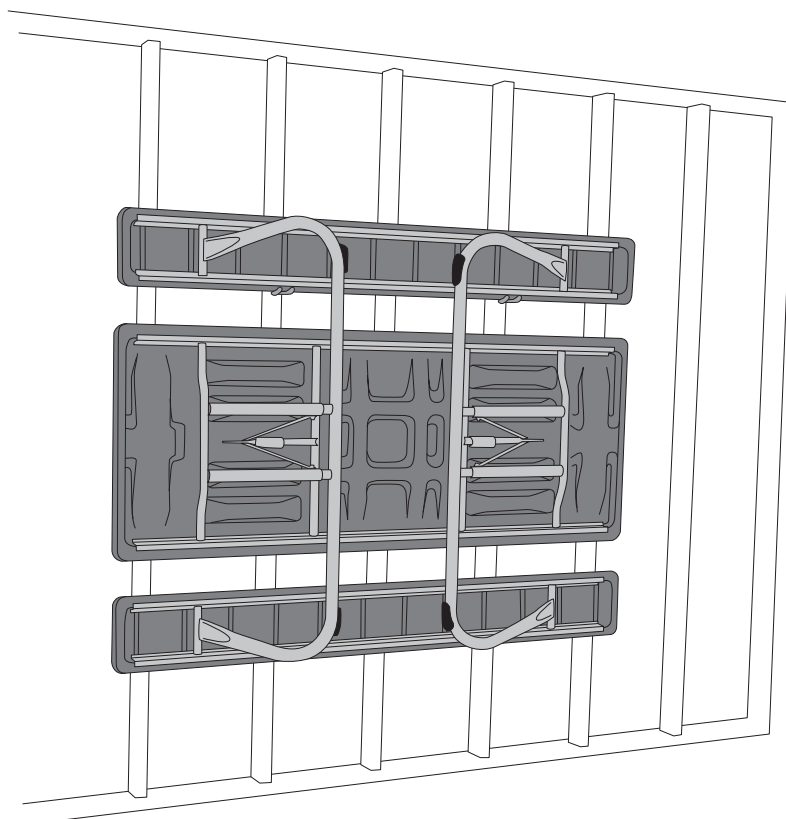
## TABLE STORAGE

### SEC 3.3

#### **\*\*TWO ADULTS REQUIRED FOR THIS STEP\*\***

Care should be taken when hanging the Table on a wall for storage. Two hooks capable of holding at least 100 pounds each are required. Securely fasten the hooks into solid framework to prevent them from coming loose and the Table from falling. For safety purposes, two people are required to hang and take down the Table to avoid any possible injuries.

## CLEANING AND CARE

Congratulations on your Lifetime purchase. By following the instructions below, your new Lifetime table should provide you with years of service and enjoyment.

### CLEANING AND CARE

The polyethylene tabletop and benches are stain- and solvent-resistant. To clean, use a mild soap and a soft-bristled brush. Abrasive cleaning materials may scratch the plastic and are not recommended. Repair scratches or rust spots on the metal frame by sanding the affected area lightly; using a rust-preventative spray primer; and finally, spraying with a high-gloss spray enamel paint. Avoid placing a direct heat source on or near the table surface unless using a heat barrier.
